4. Follow Up Items

- Yakima – Ellensburg Commuter Ellensburg boardings and de-boarding stats were shared with the committee members.
- Spencer Klewin presented an update on driver applications and new hires.
- Bruce Tabb shared there is current legislation action to do away with the 20-year TBD cap yet keep the need to go back to the voters for sales tax renewal. It was also shared the current Washington Transportation Proposal bill will most likely move through to the Senate Floor. Josh Hackney shared with the committee a sidewalk grant opportunity CWDR is reviewing.

- The Prestige Hearthstone bus stop was moved from under the facility portico to the east side of Chestnut.
- In conjunction with the Helena Complete Streets Project, they will install the Brookfield Bus Stop as well as a bus shelter at Water Street and Helena where there is currently a bus stop.
- The City Light Dept. added a light on the west side of Airport. This has really improved the lighting at the Verge.
- There was malicious mischief at 5 bus shelters in the form of the garbage cans being emptied onto the ground and strewn about. A police report was made.

9. Member Updates:

- Josh Hackney shared what CWDR is doing to educate their agency and their clients about public transit stating their staff had spent a day riding the buses. The question was asked if the display boards on the outside of the bus are also inside the bus facing passengers.

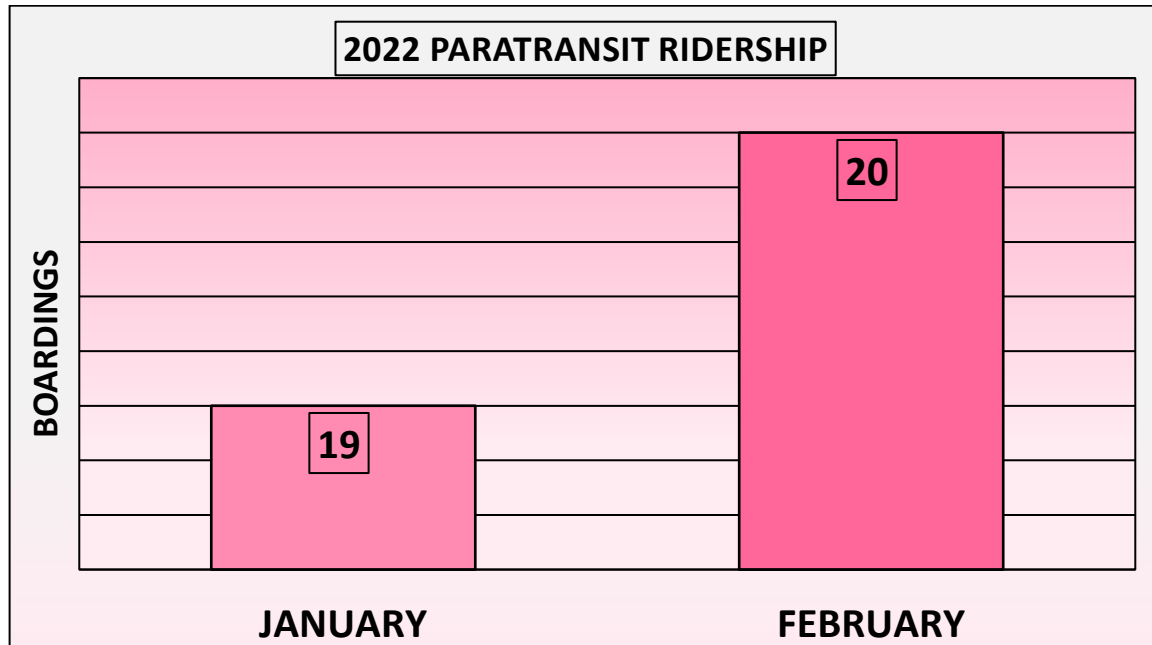

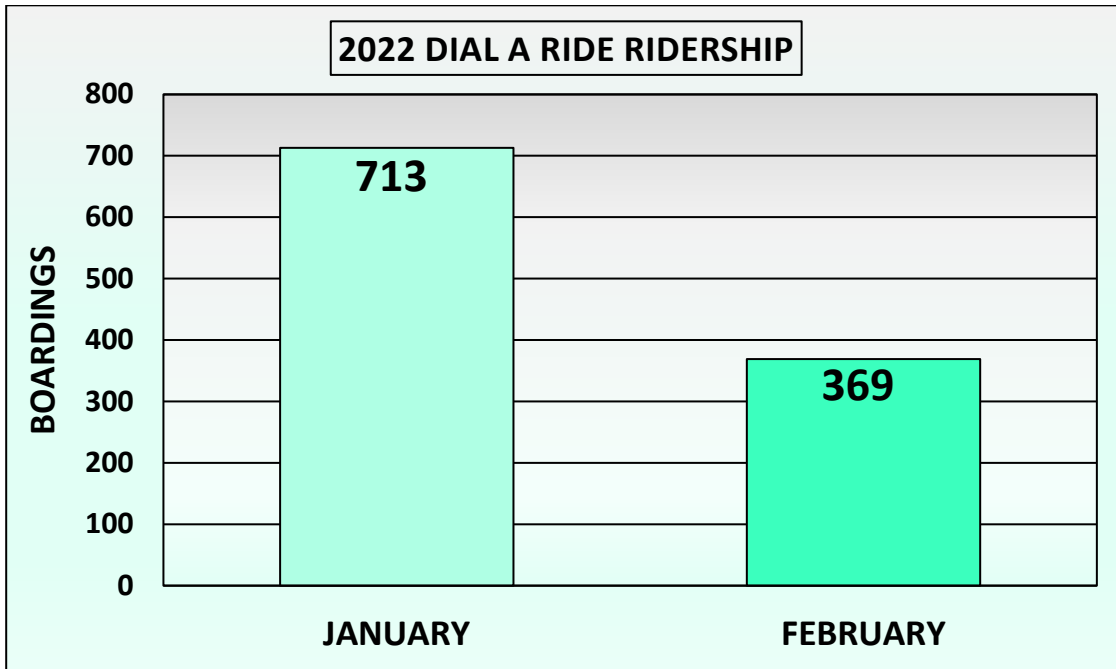

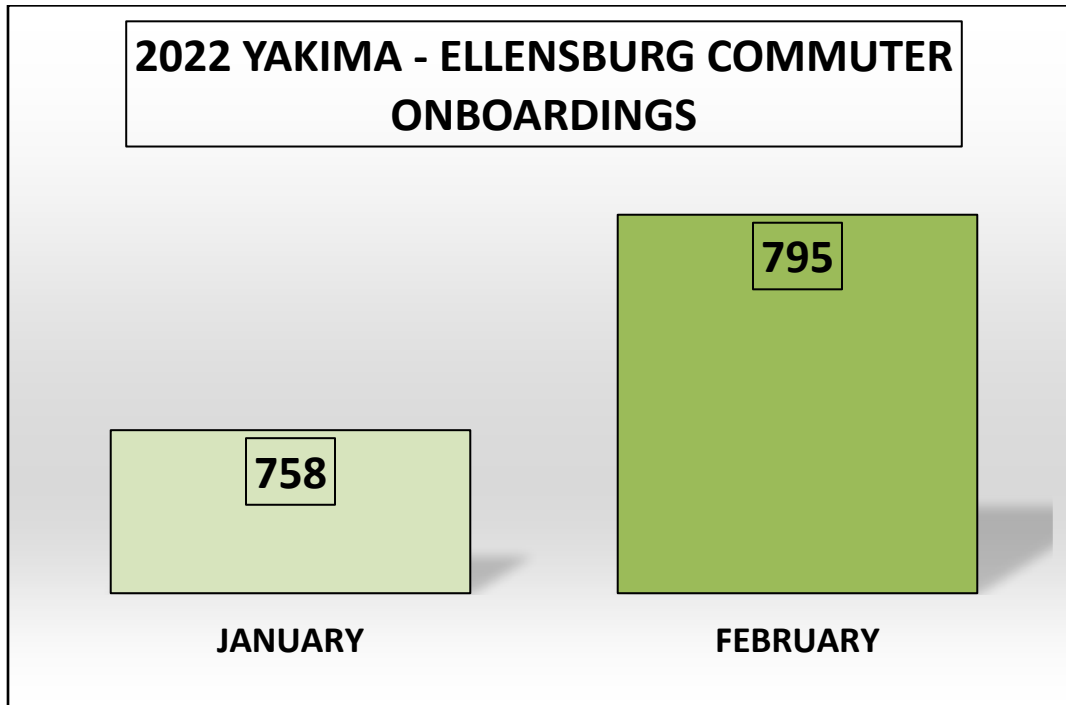

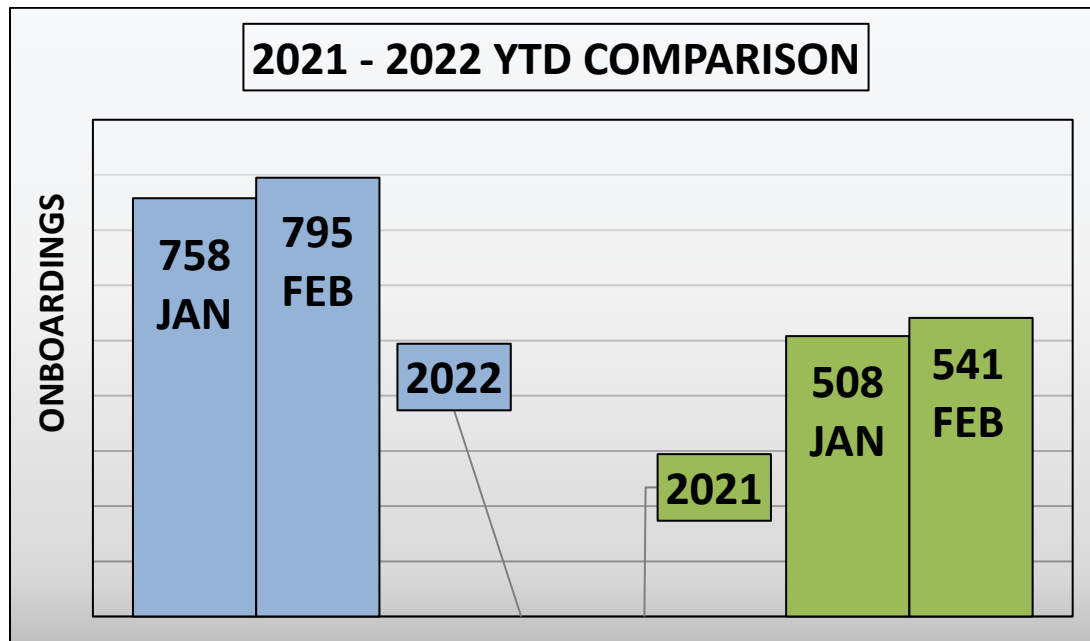
